

1. That the First Party needs the service of the Second Party who shall perform not perform by the regular personnel of the Second Party;
 2. That the Second Party has signified his intention, to which the First Party has accepted, to provide the service needed by the latter;
 3. That the Second Party hereby possesses the education, experience and skills required to perform the job as described herein;
 4. That he has not been previously dismissed from government service by reason of an administrative offense;
 5. That in view hereof, the Second Party is hereby renewed as a **Consultant** for the period of January 1, 2025 to June 30, 2025, and renewable every six (6) months thereafter and terminable at the option of either Party in consideration of monthly Honoraria of Eighty-Five Thousand Pesos (P 85,000.00);
 6. That as a **Consultant**, the Second Party is expected to perform the following functions:
 - a. Participate in determining health needs of individuals, families & community;
 - b. Carries out medical and consultation functions that include obtaining clinical history & Physical Examination;
 - c. Administering emergency and therapeutic measures;
 - d. Participate in the development progress of individual, family and community.
 - e. Perform other duties and functions as may be requested/directed by the First Party.
 7. That the Second Party shall perform work at a time and schedule to be agreed upon by both parties;
 8. That it is understood that this contract does not create an employer-employee relationship between the First Party and the Second Party, and that the latter is not entitled to benefits enjoyed by the regular personnel of the First Party.
