


WHEREAS, in response to the said advertisement, no contractor/bidders submitted Application to Bid on May 31, 2023;

RESOLVED, at the new Municipal Session Hall of Ginatilan, Cebu this 31st day of May, 2023.





WHEREAS, presented to the Bids and Awards Committee (BAC) of Ginatilan, Cebu is Purchase Request No. 100 – 23 – 104 for procurement of the following.

Residual Waste Disposal (June – December 2023)

WHEREAS, the Approved Budget for the Contract (ABC) as estimated by the Procuring Office amount to PESOS: ONE HUNDRED EIGHTY-TWO THOUSAND SIX HUNDRED PESOS (Php 182,600.00)


WHEREAS, Article XVI Section 53 of Republic Act No. 9184 allows **Negotiated Procurement** as an alternative method of procurement of goods, infrastructure projects and consulting services, whereby the procuring entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant in identified conditions/cases among which is/are the following:

Two Failed Biddings, (Sec. 53.1) Where there has been failure of public bidding for the second time as provided in Section 35 of the Act and this IRR.

(Sec.53.1.1) After conduct of the mandatory review of the terms, conditons, specifications, and cost estimates, as prescribed in Sedtion 35 of this IRR, the BAC shall revise and agree on the minimum technical specifications, and if necessary, adjust the BAC, subject to the required approvals. However, the ABC cannot be increased by more than twenty percent (20%) of the ABC for the last failed bidding.

NOW THEREFORE, on mass motion of all members present and duly seconded by the same, be it RESOVED as it is hereby RESOLVED to recommended to the Municipal Mayor the procurement of the items contained in the PR through Negotiated Procurement.
