WHEREAS, PRESENTED TO THE Bids and Awards Committee (BAC) of Ginatilan, Cebu is Purchase Request No. 100-23 - 08-109 for procurement of the following:

Procurement of Drugs and Medical Supplies

WHEREAS, the approved Budget of the Contract (ABC) as estimated by the Procuring Office amounts to PESOS: NINET-NINE THOUSAND THREE HUNDRED PESOS (Php 99,300.00) ONLY.

WHEREAS, Rule XVI Section 53 of Republic Act No. 9184 allows **NEGOTIATED PROCUREMENT** as an alternative method of procurement of goods, infrastructure projects and consulting services, whereby the procuring entity directly negotiates contract with a technically, legally and financially capable supplier, contractor or consultant in conditions/cases among which is/ are the following:


Section 53.8 Small Value Procurement (SVP). Where the procurement of (a) goods not covered by Shopping under Section 52 of the IRR of RA 9184, (b) infrastructure projects, and (c) consulting services, where the amount involved does not exceed the following threshold prescribed in 2016 Revised IRR of RA 9184 which is Php. 100,000.00 for a 5th class Municipality like Ginatilan.

Agency to Agency. Procurement of infrastructure projects, consulting services and goods from another agency of the GOP, such as the PS-DBM, which is tasked with a centralized procurement of Common-Use Supplies for the GOP in accordance with Letters of Instruction No. 755 and Executive Order No. 359, series of 1989.

WHEREAS, this COMMITTEE, after deliberation, believed that the procurement of the items contained in the above-mentioned Purchase Request falls within the afore-mentioned condition/case.

NOW THEREFORE, on mass motion of all members present and duly seconded by the same, be it RESOLVED as it RESOLVED to recommend to the Municipal Mayor the Procurement of the items contained in the PR through Negotiated Procurement.
