

# MUNICIPALITY OF GINATILAN, CEBU

## Invitation to Bid for the Expansion, Rehabilitation & Improvement of Municipal Water System in Barangay Looc, San Roque & Palanas

1. The **Municipality of Ginatilan, Cebu**, through the **GF-20% EDF CY 2024** intends to apply the sum of **Nine Hundred Six Thousand Pesos Only (Php 906,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Expansion, Rehabilitation & Improvement of Municipal Water System in Barangay Looc, San Roque & Palanas – 2024-49**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Municipality of Ginatilan, Cebu** now invites bids for the above Procurement Project. Completion of the Works is required **forty five (45) days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **Municipality of Ginatilan, Cebu** and inspect the Bidding Documents at the address given below from **8:00 AM to 5:00 PM**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **November 19 to 27, 2024** from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **One Thousand Pesos Only (Php 1,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
6. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before **November 27, 2024, Wednesday at 1:00 PM**. Late bids shall not be accepted.
7. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 15**.
8. Bid opening shall be on **November 27, 2024, Wednesday at 1:30 PM** at the given address below. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.
9. The **Municipality of Ginatilan, Cebu** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
