WHEREAS, presented to the Bids and Awards Committee (BAC) of Ginatilan, Cebu is Purchase Request No. 100-22-07-*075* for procurement of the following.

Repair and Maintenance Transportation Equipment

WHEREAS, the Approved Budget for the Contract (ABC) as estimated by the Procuring Office amount to PESOS: SEVEN HUNDRED SEVENTY NINE THOUSAND FIVE HUNDRED SEVENTEEN PESOS (Php. 779,517.00) ONLY.

WHEREAS, Article XVI Section 53 of Republic Act No. 9184 allows **Negotiated Procurement** as an alternative method of procurement of goods, infrastructure projects and consulting services, whereby the procuring entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant in identified conditions/cases among which is/are the following:

A Two Failed Biddings, (Sec. 53.1) Where there has been failure of public bidding for the second time as provided in Section 35 of the Act and this IRR.

(Sec. 53.1.1) After conduct of the mandatory review of the terms, conditions, specifications, and cost estimates, as prescribed in Section 35 of this IRR, the BAC shall revise and agree on the minimum technical specifications, and if necessary, adjust the ABC, subject to the required approvals. However, the ABC cannot be increased by more than twenty percent (20%) of the ABC for the last failed bidding.

NOW THEREFORE, on mass motion of all members present and duly seconded by the same, **be it RESOLVED** as it is hereby RESOLVED to recommend to the Municipal Mayor the procurement of the **items** contained in the PR through Negotiated Procurement.
