(Sec. 53.1.1) After conduct of the mandatory review of the terms, conditions, specifications, and cost estimates, as prescribed in Section 35 of this IRR, the BAC shall revise and agree on the minimum technical specifications, and if necessary, adjust the ABC, subject to the required approvals. However, the ABC cannot be increased by more than twenty percent (20%) of the ABC for the last failed bidding.

NOW THEREFORE, on mass motion of all members present and duly seconded by the same, be it RESOLVED as it is hereby RESOLVED to recommend to the Municipal Mayor the procurement of the items contained in the PR through Negotiated Procurement.
