RESOLUTION NO. 162

WHEREAS, PRESENTED TO THE Bids and Awards Committee (BAC) of Ginatilan, Cebu is Purchase Request No. 100 - 24 - 12 - 117 for the following:

Repair & Maintenance of Transportation Equipment

WHEREAS, the Approved Budget of the Contract (ABC) as estimated by the Procuring Office amount to PESOS: SEVENTY-THREE THOUSAND NINE HUNDRED SIXTY PESOS (₱ 73,960.00) ONLY;


WHEREAS, Article XVI Section 52 of R.A. 9184 allows @Shopping@ as an alternative method of procurement whereby the procuring entry simply requests for the submission of price quotations for readily available off-the-shelf goods or ordinary/regular equipment to be procured directly from suppliers of known qualification, that this method of procurement shall be employed only in any of the following cases.

- Where there is an unforeseen contingency requiring immediate purchase; provided, however, that the amount involved does not exceed the following threshold in prescribed in 2016 Revised IRR of RA 9184 which is ₱ 100,000.00 for a 5th class Municipality like Ginatilan;
- Procurement of ordinary or regular office supplies and equipment not available in the procurement Services involving an amount not exceeding the threshold prescribed in Annex "H" of the revised IRR Provided, further, that at least three (3) price quotations from bona fide suppliers be obtained;

WHEREAS, this committee noted that the ABC of the above-mentioned PR and its procurement falls within category (a) of the preceding paragraph;


NOW, THEREFORE, on mass motion of all members present and duly seconded by the same, be it RESOLVED as it is hereby to recommend to the Municipal Mayor the procurement of the items contained in the PR through SHOPPING, an alternative method of procurement.
