





WHEREAS, presented to the Bids and Awards Committee (BAC) of Ginatilan, Cebu is Purchase Request No. 100 – 20 – 03 - 06<sup>v</sup> for procurement of the following.

Procurement of Comm. and IT Equipment (Laptop, Printer)

WHEREAS, the Approved Budget for the Contract (ABC) as estimated by the Procuring Office amounting to PESOS: ONE HUNDRED FIFTY-THREE THOUSAND SEVEN HUNDRED NINETY PESOS (Php. 153,790.00) ONLY.

WHEREAS, Article XVI Section 53 of Republic Act No. 9184 allows **Negotiated Procurement** as an alternative method of procurement of goods, infrastructure projects and consulting services, whereby the Procuring Entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant in identified conditions/cases among which is/are the following:

**Emergency Cases, Section 53(b) of RA No. 9184 and Section 53.2 of its 2016 IRR** shall be allowed in the following instances:

- (a) in case of imminent danger to life or property during a state of calamity
- (b) when time is of the essence arising from actual or man-made calamities; or
- (c) other causes where immediate action is necessary to prevent damage to or loss of life, property, or to restore vital public services, infrastructure facilities and other public utilities

WHEREAS, **GPPB Resolution No. 03-2020** - The instances or situations where the foregoing conditions may be applied include the provision of immediate response and initial recovery steps to avoid loss of life, injury, disease and other negative effects on human, physical, mental and social well-being, together with damage to property, destruction of assets, loss of services, social and economic disruption and environmental degradation.

NOW THEREFORE, on mass motion of all members present and duly seconded by the same, be it **RESOLVED** as it is hereby **RESOLVED** to recommend to the Municipal Mayor the procurement of the items contained in the PR through Negotiated Procurement (Emergency Cases).
