CONTRACT AGREEMENT

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c) Performance Security;
- d) Notice of Award of Contract and the Bidder's conforme thereto; and
- e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of TWO HUNDRED SIXTY NINE THOUSAND SIX HUNDRED FIFTY NINE PESOS & 13/100 ONLY (Php 269,659.13) or such other sums as may be ascertained. RAJ LAURENTE CONSTRUCTION & DEVELOPMENT PHILIPPINES agrees to CONSTRUCTION OF SEEDLING SHADE HOUSE in accordance with his/her/its Bid.
- The MUNICIPALITY OF GINATILAN, CEBU agrees to pay the above-mentioned sum in accordance with the terms of the Bidding
