

## CONTRACT AGREEMENT

THIS AGREEMENT, made this 15th day of December, 2023 between MUNICIPALITY OF GINATILAN, CEBU (herein called the "Entity") and RAJ LAURENTE CONSTRUCTION & DEVELOPMENT PHILIPPINES – Lawaan I, Talisay City, Cebu (herein called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **SOLAR STREET LIGHT PROJECT ALONG BARANGAY ROADS (SOLAR LIGHT LAMP POST) – 2023-36** (herein called "the Works") and the Entity has accepted the Bid for **TWO MILLION SIX HUNDRED SIXTY FOUR THOUSAND TWO HUNDRED SIXTY SIX PESOS & 43/100 ONLY (Php 2,664,266.43)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WINESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised implementing Rules and Regulation of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:

a) Philippine Bidding Documents (PBDs)

- i. Drawings/Plans;
- ii. Specifications;
- iii. Bill of Quantities;
- iv. General and Special Conditions of Contract;
- v. Supplemental or Bid Bulletins, if any;

b) Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;


c) Performance Security;


d) Notice of Award of Contract and the Bidder's conforme thereto; and

e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **TWO MILLION SIX HUNDRED SIXTY FOUR THOUSAND TWO HUNDRED SIXTY SIX PESOS & 43/100 ONLY (Php 2,664,266.43)** or such other sums as may be ascertained. RAJ LAURENTE CONSTRUCTION & DEVELOPMENT PHILIPPINES agrees to **SOLAR STREET LIGHT PROJECT ALONG BARANGAY ROADS (SOLAR LIGHT LAMP POST)** in accordance with his/her/its Bid.
4. The MUNICIPALITY OF GINATILAN, CEBU agrees to pay the above-mentioned sum in accordance with the terms of the Bidding
