

MUNICIPALITY OF GINATILAN, CEBU

REQUEST FOR EXPRESSION OF INTEREST FOR GEOTECHNICAL / SOIL EXPLORATION PROJECT FOR THE PROPOSED CONSTRUCTION OF BRIDGE

1. The **Municipality of Ginatilan, Cebu**, through the **GF-20% EDF CY 2023** intends to apply the sum of **Two Hundred Sixty Eight Thousand Eight Hundred Pesos Only (Php 268,800.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Geotechnical / Soil Exploration Project for the Proposed Construction of Bridge – 2023-17**. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
2. The **Municipality of Ginatilan, Cebu** now calls for the submission of eligibility documents for **Conduct Geotechnical / Soil Exploration specifically Soil Boring/Drilling (3BH @ 30.0 meters) Laboratory Testing (Routine test, NMC, SA, AL) & Technical Evaluation Reports**. Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before **July 3, 2023, Monday at 1:00 PM at Ginatilan New Municipal Session Hall**. Applications for eligibility will be evaluated based on a non-discretionary “pass/fail” criterion.
3. Interested bidders may obtain further information from **Municipality of Ginatilan, Cebu** and inspect the Bidding Documents at the address given below during **8:00 AM to 5:00 PM**.
4. A complete set of Bidding Documents may be acquired by interested Bidders on **June 21 to July 3, 2023** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Hundred Pesos Only (Php 500.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

5. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”, and its Implementing Rules and Regulations (IRR). The short list shall consist of **one (1)** prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:

Experience of the Firm	- 60 pts.
Availability of Required Personnel of the Firm	- 10 pts.
Workload	- 30 pts.
TOTAL	- 100 pts

Eligible bidder must obtain the passing score of **Eighty (80) Points** to qualify in the shortlist.


6. A shortlisted association cannot disassociate from each other; otherwise, its members should be rejected. Neither can a short listed firm be allowed to associate with any other firms.
7. Prospective Bidder must indicate the **amount** of any of the consulting services listed below for projects undertaken (**TECHNICAL ASPECTS: EXPERIENCE ON COMPLETED PROJECTS, GOVERNMENT & PRIVATE**) and of the proposed Team Leader/Project Manager (Curriculum Vitae) on the Eligibility Screening Forms.

7.1 Geotechnical Investigation / Surveys

7.2 Soil Exploration / Investigation (Including Sub-surface Soil Exploration).

8. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised IRR of RA 9184.
9. Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
10. The Procuring Entity shall evaluate bids using the **Quality-Cost Based Evaluation/Selection (QCBE/QCBS)**. The **Technical and Financial Proposals** shall have weights of **sixty five percent (65%)** and **thirty five percent (35%), respectively**. Shortlisted bidder whose technical proposal passed the minimum technical score of **eighty percent (80%)** shall be invited for the opening of financial proposal and negotiation. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.
11. The contract shall be completed within **30 calendar days**.
12. The **Municipality of Ginatilan, Cebu** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
