

BAC Resolution Declaring LCRB and Recommending Approval

WHEREAS, the Municipality of Ginatilan, Cebu advertised/posted the Invitation to Bid/Request for Expression of Interest for the project *Procurement of Info. & Comm. Tech. Equipment* at LGU Website and in a conspicuous place at the premises of the Municipality of Ginatilan, Cebu continuously for 7 calendar days per GPPB Res. No. 014-2006,

WHEREAS, in response to the said advertisement (2) bidders submitted application for eligibility and two (2) were found eligible on March 6, 2023,

WHEREAS, two bids submitted and opened on March 6, 2023 and these bids passed the preliminary examination of bid;

WHEREAS, the bid proposal of the eligible bidder was found to be substantially complying;


NOW THEREFORE, we the Members of Bids and Awards Committee hereby RESOLVE as it is RESOLVED:




