WHEREAS, the detailed evaluation of bids conducted on November 4, 2022 resulted in the following;




NOW THEREFORE, we the Members of Bids and Awards Committee hereby RESOLVE as it is RESOLVED:

RESOLVED, at the Municipal Session Hall of Ginatilan, Cebu this 4th day of November, 2022.


